
CVHS PTO General Meeting Meeting, Zoom October 27, 2022

- I. Call to Order: Maria Calzada at 7:04 pm
 - A. Welcome, this is our second meeting.
 - B. There have been some questions as to why Zoom versus in person. At the end of last year when we started doing in person or hybrid meetings. What we found with our 100% Magnet population, meaning we are not a neighborhood school We had very low in person attendance. III. Proposed Amendment to PTO Bylaws: Marlo Rooney Larkin

- A. We are proposing to amend our bylaws to help our Treasurer. What is currently in the bylaws reviewed on the screen and read aloud. We have discussed this and thought that was a lot of responsibility on the Treasure. The proposed amendment is shown on the screen with PTO Executive Board approval. Specifically funding requests that were to be approved by Treasurer alone moving to Executive Board vote include any of the following criteria 1) if the amount request exceeds 10% of that category 2) Or if the amount requested exceeds \$1500 regardless of category, 3) Or the if requesting group has already been granted financial request from PTO in any amount. In summary, the change in budget funding from Treasurer alone to Executive Board vote. Further documentation in Agenda.

IV. Treasurer's Report : Mala Gupta

- A. Speaking of money and transparency... Next is Mala our Treasurer. Hi everyone, this is Mala, Treasurer, can you hear me? Thank you for passing that motion. Last year people asked, why do you bring this to vote? I appreciate it because I feel it shouldn't be one person deciding, and thank you. I'm sure future Treasurers will appreciate it. Board for making that into an amendment.
- B. Coming to our meeting, I want to present our Financial Statement this year, up till now. This is a statement of Activity from July 1, 2022 -I October 18, 2022. I made it for last week's meeting, so it is behind just one week. From July 1, 2022 we have our revenue from Friends and Family campaign that is our major source. We get some from selling swag or through Randalls / Kroeger. We are now at 22% of our goal. We have a thermometer on the website to show that. Please also list CVHS PTO under your Amazon Smile, Randalls, Kroegers. Speaking of our expenses, this is from our teacher requests, \$350 per teacher. It is very early on this year. That summarizes our expenses and revenue so far.

- D. I want to request if you have a corporate matching program in your company. I love paperwork and am not afraid of it. Please reach out to me and we can get that ball rolling. That's pretty much it. Thank you to our generous CVHS family for your donations and support. The revenue shown is based off last week, 22%, about \$22,000.
